



Privacy Policy

Protecting your confidential information is our priority. This Statement of Privacy applies to www.iNcarnate247.com and Creative iNcarnate LLC. And governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to iNcarnate LLC. Include www.incarnate247.com, iNcarnate, @iNcarnate247 and the Creative Collective. Collection of Personal Information

To better provide you with products and services offered, iNcarnate may collect personally identifiable information such as:

- First and Last Name
- Mailing Address
- E-mail Address
